"FROM THE PRESIDENT'S PEN"

Dear Members.

I trust you are keeping dry and warm as we seem to be experiencing some real extremes of weather this winter. First a lack of snow, then drifts and blizzards which even close

off the ski fields temporarily, heavy downpours that saturate the ground for some days and weeks and gale-force winds. Quite weird, what have we humans done to the planet? Of course, Engineers know how to work with nature, but it is a real challenge when nature works against you, as in the case of the Christchurch earthquake situation. Having been down there several more times in recent months and in meeting with the City Council, CERA representatives and others working on the recovery, deconstruction and remediation, as well the planning and reconstruction, it is a sombre, albeit challenging opportunity to rebuild Christchurch to survive these natural disasters and continual after-shocks and secure its future for many years to come. As I mentioned in my last editorial, it is good to see the part that RNZE has and are playing in assisting with the major recovery situation.

On another sad note, we offer our heart-felt condolences and sympathies to Joyce Rutherford and families of the late Col Ken Rutherford, who passed away in Auckland on 21 May 2011. Apart from being Chief Engineer, Director of (Defence) Works and Col Comdt (or Hon Col) RNZE (1993-97) during his outstanding military career, he was also a staunch and valued member of the Sappers Association, since its formation in 1960. Dear Ken was a long-standing member, committee man, Treasurer, Convenor and Guardian of the Funds, a recipient of the Meritorious Service Award (2004) and Vice-Patron of the Association from 2005. He was always one of the mainstays of the Auckland (now Northern) Branch and Engineer Reunion organising team, along with him being a key player in establishing the Association bursary scheme and also in improving the communications and welfare contact throughout NZ. His leadership and support of the Auckland Sapper Officers' Mess is also noteworthy. We wish the wider Rutherford family a long life and may he rest in peace and be in our fond memories forever.

We now have the RNZE Charitable Trust in place, which was incorporated on 12 May 2011 and became a registered charity approved by the Charities Commission on 14 July 2011. The objects and purposes of the Trust are quite succinct and are stated as follows:

To maintain, develop and preserve research, historical records, artefacts, collections and memorabilia of the Corps of Royal New Zealand Engineers (RNZE) for the purposes of :

- 1. Illustrating to the public the role the RNZE has played in the establishment and development of New Zealand infrastructure and New Zealand military and engineering history; and
- 2. Providing the New Zealand Defence Force/New Zealand Army with an aid in the teaching of military and military engineering history.

The Trust Board comprises our Patron, Hon Col George Butcher, Col Anthony Wilson (Col Comdt, RNZE), Lt Col Don Jones (CO and Regt Col), Maj Mike Pettersen (Regt XO), Clas Chamberlain (Deputy Chair and Hon Curator ECMC), WO1 Brent Wilson (Secretary/Treasurer and SSM, SME) and myself as Chair. We had a preparatory meeting on 9 June and are in the process of establishing accounts and other requirements of the Trust. We now wish to attract contributions towards the Trust so that we can build up our funds to support both the reconfiguration and refurbishment of the ECMC library and museum, but also the RNZE Corps History project. I am sure that other projects will emerge in the future and I will keep you informed of further progress with the Trust.

Speaking about the history project, both Lt Cols Don Jones and Todd Hart have made further progress in finalising the agreement with the Ministry of Culture and Heritage (MCH), so that we can get some activity underway. A trial interview will commence soon with Clas Chamberlain, so that we can work our way through the detailed questionnaire being used to collate base information. A prioritised interview list has been agreed, so that we will 'collect' a number of key contributors in a few locations so that further questionnaires and

interviews can be completed. It is intended to conduct a minimum of 12 interviews over the next 11 months and have this phase of the project concluded by 30 June 2012. MCH will ensure that copies of the interview tapes and videos, probably stored on CDs/DVDs, will be available at the National Library and also at the ECMC at Linton Camp. More information will be provided as this project progresses, but we will also be looking for financial contributions to add to the funds allocated to this project. Currently, NZDF/Army has committed to providing some financial support, along with funds from the new RNZE Charitable Trust.

We apologise for the delay of the April newsletter, for reasons already explained, which were totally beyond our control. I understand that the remaining reports from our AGM on 20 March 2011 will be provided elsewhere in this latest issue, which we hope will bring you all up to date. It is intended that this (August) newsletter still come out on time, regardless of the last issue being delayed. I understand that the various ANZAC Day celebrations went well about the country, as we now look forward to Sappers Day soon, this time observed on a Saturday! Also a reminder about the Riccarton Road (and Addington Barracks) Reunion, based out of the Papanui RSA in Christchurch, over the weekend 28-30 October 2011 (and after the RWC)! It would be great to get some feedback, reports and photos on all of these activities within the branches about NZ, which we can share with you by way of our last newsletter for the year, which should be available before the close of the end of this year in December.

That should bring you up to date with developments over recent months and since the last issue. Just remember that all of the work undertaken by your Executive Council and branch committees is voluntary and totally dependent upon individuals and their available spare time. We really do appreciate the efforts that many of our committee members put in to try and keep the affairs of the Association moving along. A few more willing helpers and financial contributions would also be very much appreciated!

Howitzer back in front line (front page photo)

For more than 12 years, a World War II howitzer gun stood as a symbol of military pride on the street in front of Palmerston North RSA's clubrooms.

Passersby may have wondered why the green gun disappeared from the footpath outside the Broadway Ave building last year – but it had not gone far.

The gun spent several months in the garden near the Returned and Services Association restaurant, but was restored to a position of prominence in the clubrooms' car park yesterday.

Three Linton Military Camp engineers from the 25 Engineer Support Squadron spent two days constructing a concrete stand for the gun, complete with a sandbag-shaped base.

Staff Sergeant Terry Grant said about 14 soldiers were needed to roll the gun on to the stand.

"They had no problems at all," he said. "They did it on time and to budget. It was a pretty good job, especially because it was for the RSA. It keeps us in touch with them."

The RSA provided the materials for the stand but Staff Sergeant Grant said the army gave labour for free.

The Linton Military Camp gifted the M2A2 105mm field artillery to the RSA in 1998.

Palmerston North RSA president Gary Griggs said he was happy the gun had been moved as it was a source of pride for club members.

"I think it's really good where it is now. A lot of the RSA members take their photos with it and I think they will be taking more photos now."

Palmerston North RSA chief executive Lindsay McKinney said the gun had been used in combat but he was unsure how many times.

"It's definitely fired shots in anger in Vietnam but I think it would have caused more injuries here," he said.

"We've all cut ourselves on it, and twisted ankles and dropped it on toes."

Mr McKinney said the gun was removed from the street because the RSA no longer owned the front part of the building.

"When the building was renovated, we sold that part of the land. It's probably better where it is now though."

The M2A2 105mm field gun was used extensively by the United States Army and Marine Corps during World War II and the Korean War, and then by New Zealand forces in the Vietnam War.

The 161st Battery of New Zealand's 16th Field Regiment adopted the weapon in late 1966 or early 1967, to replace the 105mm Italian howitzer.

North Otago's Unique War Memorial



Memorials to the war dead come in many forms, be they humble headstones, civic war memorials or cenotaphs. They are usually of stone, and can be found in almost every corner of New Zealand, both urban and rural. Each Anzac Day services are held at these memorials to remember those who died in defence of their heritage and peace.

But in North Otago there is a different form of memorial. Observant travellers through the district will have noticed magnificent oak trees at mile intervals in rural areas, with a small white concrete cross beneath. These trees are Memorial Oaks and how they came to be dotted along our highways and town streets is fascinating.

In 1913, the Antarctic supply ship, Terra Nova anchored off Oamaru Harbour, to allow two seamen to relay the sad news of the demise of Captain Robert Falcon Scott and his four companions on their return journey from the South Pole.

The Oamaru Beautifying Society planted an oak tree on the path that the sailors too on their way to the Harbour Master's house. Soon after that, World War I broke out, with all its attendant horrors of trench warfare on the Western Front. By 1918 few families in New Zealand were unaffected by the result, most families knowing somebody who had lost their life on foreign soil, and the question arose of how to remember them. In most cases, bodies were not able to be repatriated, and so there was no grave or headstone to mourn over. The President of the Oamaru Beautifying Society knew people wanted a permanent memorial, but not one that glorified war. He suggested enlarging the Scott Memorial oak scheme with an oak tree for each soldier, as near to where they lived as possible. The authorities were delighted and invited families to apply. Over 400 names were put forward and soon oak trees were planted along the rural roads from Oamaru to Kurow, Weston to Livingstone, Oamaru to Shag Point, and along town streets in Oamaru as well. The scheme is unique since each tree is a living memorial to an individual.

Slowly over the years some of the trees have been lost due to power lines, road widening and becoming busier, and the oak trees were removed when they become inconvenient.

In the 1950's an effort was made to save the oaks by re-planting in groves where they become a collective memorial. But in the 1990's the North Otago branch of the Historic Places Trust alerted people to the plight of the remaining oaks and a committee was formed to survey the entire scheme, research each tree and the soldier to whom it belonged, and have cast and engraved a concrete cross to be placed under each tree.

Today there are 220 trees with memorial crosses and they remain a living memorial to fallen heroes, just as the founders of the Scheme had intended all those years ago.

Eulogy - Major Colin Douglas, Royal New Zealand Engineers.

Much more than just a soldier; he was also son, a brother, an uncle, a husband, a father, a grandfather, a great grandfather and a friend. Colin had two families central to his entire life – his familial one and the military, both of which he served with honour and distinction. Those that knew Colin will remember a generous friend who gave willingly of his time, expecting nothing more in return than honesty and genuine effort. He was uncompromising in his standards, both in his own endeavours and of those upon whom he relied. Colin didn't suffer fools gladly and was always quick to point out ways where improvements could be made. There were very few shades of grey in Colin's world; he saw things in black & white. You were either doing the right thing, or you weren't and you were left in no doubt that if you wanted his assistance, you had better make sure that what you were doing was 100% legal and appropriate. I have in my life, never met another soul with as much integrity or as strong a morale compass as that possessed by Colin. As a father, he provided an uncompromising example and set standards that anyone would be proud to achieve. As a commanding officer, he was dedicated, honest and fair, and every bit as demanding as he was in his private life. These deeply ingrained qualities helped shape his life and the lives of those around him, both within his family and his professional career.

As a professional soldier, Colin served New Zealand over five decades, willing to put his life on the line in support of others, not for glory and certainly not for the pay check, but because it was the right thing to do. His life as an engineer began during the great depression, as a Carpentry Apprentice with the Otago Education Board at the age of 13. He worked hard, completed his apprenticeship and continued to study in the evenings at Technical College where he learned construction and engineering. All this while holding down a day job to help support his mother and father. Colin was heavily involved in the Scouting movement and at the age of 19 met his wife to be, Rata Ramsay. It was now 1941 and the NZ Govt was asking for volunteers to complete three months of military training to form the basis of a larger standing army to meet the growing need in Europe and to blunt the more local threat posed by Japan. Colin signed up and on completion became an instructor at Burnham camp. In September 1942 Colin completed Officer training and as a shiny new 2nd Lieutenant was posted to the 1st Otago Regiment. In November 1942, Colin married Rata and after a brief honeymoon in Wellington, he was posted overseas. At the time, the threat from Japanese forces had receded to the point where recently commissioned officers were asked to either return to civilian life or to give up their commission and serve overseas at the rank of Sergeant. By November 1943, Sergeant Douglas, was involved in very heavy fighting with 23 Battalion in Italy, slowly advancing northwards towards Rome.

Now a platoon commander, Colin fought intense engagements culminating in the now famous attack to wrest the Casino monastery from German control. Colin was subsequently wounded by a German 88MM shell fragment in an action close to the Italian city of Florence. This effectively ended his active involvement in the fighting and he spent the remainder of the war running the military hospital in Bari. This allowed him time to develop a close bond with both Italy and the Italian people. This very strong bond stayed with him for the remainder of his life, influencing his taste in music and food. At the end of the war, Colin, along with so many others was de-mobbed and headed back to civilian life. His carpentry skills provided a home for him as a woodworking teacher at Hawera High School, where he also taught mathematics and technical drawing. After several years of civilian life, Colin was drawn back to the military and joined the Royal New Zealand Engineers at the rank of 2nd Lieutenant. After various postings and promotions, Colin, now a Captain became the CO and Chief Instructor of the School of Military Engineering at Linton Military Camp. He was later promoted to Major and posted to 2 Construction Squadron as the Commanding Officer. The following years saw him represent the Royal New Zealand Engineers in Australia and Hawaii where he was tasked with learning new engineering techniques to bring home and pass on.

This knowledge proved invaluable when he lead a team of Army engineers, the first people on site, in atrocious weather conditions to rescue survivors and recover bodies from the Tangiwai disaster – New Zealand's worst train crash. It would have been easy to delegate the role to a subordinate and direct efforts from the safety of his office – but that wasn't Colin's style. He lead from the front and took personal responsibility for the task, because it was the right thing to do. Years later, the RAF covered themselves in glory when visiting nearby Ohakea Air base, a Vulcan bomber had taxied off the runway and got completely stuck in the mud. No amount of coaxing would get the bomber, which had sunk down over the top of the wheels, out of the mud and so the Army engineers were brought in to rescue the Air Force. Colin's imaginative solution was to use giant air-bags under the wings to spread the load and gently lift the airframe free from the mud allowing metal plates to be placed under the wheels and the aircraft to be recovered. These days this would be considered a pretty routine recovery, but in the early sixties, this was a ground-breaking (excuse the pun) technique, which earned Colin and the Royal New Zealand Engineers great kudos within the armed forces family both at home and in Britain.

After a period serving as the Commanding Officer of the Southern Army Region in Christchurch, Colin was seconded to the United Nations as a Military Observer, an un-armed peacekeeper in the Middle East. Based initially in Damascus in Syria and manning observation posts in no-man's land between Syria and Israel on the Golan Heights, Colin's organisational skills guickly impressed his superiors and he was re-assigned as Operations Officer in the very busy UN base at Tiberias, in Israel. He continued to excel and 2 years later was seconded by the Commander of all UN Forces in the Middle East, a Finish officer, General Salisvo, to headquarters in Jerusalem. Now at the end of his 2 year secondment and first year extension, the New Zealand Army wanted Colin back. It was unknown for any New Zealand officer to be granted two extensions and the NZ Army were keen not to set a precedent. General Salisvo however personally asked UN Secretary General Kurt Waldheim to intercede and get New Zealand approval for a further 1 year's extension. Reluctantly, Army HQ relented. This was a highly volatile period in the Middle East, and included the 1973 Yom Kippur war, where Colin lost several friends, United Nations officers killed in action during the fighting. Among them Carlo Oliveri, an Italian officer with whom Colin had become particularly close. During the Yom Kippur conflict, General Salisvo was stranded in Damascus and used Colin as his proxy in Jerusalem to prepare and coordinate the UN response to events as they unfolded. During this period Colin oversaw the introduction of Russian officers into the UN observer role and was pivotal in the very sensitive negotiations to secure agreement between the Israeli and Syrian governments for their placement despite vocal objections from America. The historic document agreeing to the Russian officer deployments bears the signatures of the Syrian President, the Israeli Prime Minister and our very own Major Colin Douglas. This document is held in the secure archive at UN Headquarters in New York.

During his time in Jerusalem, Colin worked closely with an Austrian officer, Hans Hobisch. Interestingly, Hans had been drafted into the German Army during the second world war and served in Italy at the same period as Colin. After some analysis between the pair, it became apparent that they had been positioned less than a kilometre from each other in Italy for a period of several weeks. One thing they both joked about was that during the Casino campaign, "when the British bombed, the Germans took cover, when the Germans bombed, the Allies took cover. But when the Americans bombed, everyone took cover!" It seems that some things are timeless.

On his eventual return to New Zealand, Colin took up the role of 2IC or second in command at Linton. This was a position he held until he retired at the age of fifty-five. Family was always important to Colin and Rata and they spent the remainder of their lives visiting daughter Glenys and son John overseas and doting on their grandchildren and remaining active with championship level lawn bowls. Always a keen observer of military and political events, Colin took a strong interest in current affairs, watching the news and debating the outcome with anyone foolish enough to venture an opinion.


